

Current Report 15/2020 Resolutions adopted by BOŚ S.A. Ordinary General Meeting on 17 June 2020 – publicised on 17 June 2020.

In accordance with Par. 19 Section 1 Items 6,7,8 and 9 of the Finance Minister's Ordinance of 29 March 2018 on current and periodic information presented by issuers of securities and on the terms of acceptance as equivalent of information required by the laws of a non-member state (Journal of Laws of 2018, item 757), the Management Board of Bank Ochrony Środowiska S.A. domiciled in Warsaw („Bank”) attached hereto publicises the wording of resolutions adopted by the Bank Ordinary General Meeting (“OGM”) held on 17 June 2020, including information on the number of shares with which valid votes were cast, on the percentage of those shares in the share capital and on the total number of valid votes “for”, “against” and “abstentions”. Further, the Bank Management Board hereby informs that all the documents which were voted on, had been published in current and periodic reports which are available on Bank's web site, in the Investor Relations tab.

All the draft resolutions voted on have been adopted by the OGM.

Additionally, the Bank Management Board hereby informs that during the OGM no objection to the meeting minutes was raised with regard to the adopted resolutions and that all the agenda items were considered.
